

OUTLINE SUMMARY OF PROPOSED CHANGES

Article I: Name	Minor wording	Changed "will be" to "is" in the organization's name description.
Article III: Membership	Minor wording and formatting	<p>Added subheadings like "Dues", "Cutoff", "Board Granted" under Life Membership (3.3). Changed "exemplified himself" to "exemplified" in Honorary Membership (3.5).</p> <p>Updated references to "General Membership Meeting" or "Board Meeting" to "Association Meeting". Changed voting for Honorary and Special Membership from "three-fourths vote of the Board Members present" to "three-fourths majority vote of the Board Members present". In Conditions of Membership (3.9), changed "Board of Directors' meeting" to "Association meeting". Added "Sponsorship of New Members" as 3.9.1 with minor rephrasing. Added "Membership Chairman Responsibility" as 3.10. In Dues and Fees (3.11), changed ratification to "Association Meeting" and added notification reference (Ref 8.1.1). Updated Guest section (3.13) with "Guest Participation" subheading. </p>
Article IV: Executive Officers (Original) / Board of Directors (Revised)	Major restructuring	<p>Original Article IV (Executive Officers) and Article V (Board of Directors) combined into revised Article IV (Board of Directors). Executive Officers now elected from within the Board. Added duties, terms, and remote attendance policies (4.5.1). Introduced detailed removal process via petition (4.6-4.7). </p>

Article V: Board of Directors (Original) / Board Officers (Revised)	Major restructuring	Original Article V moved to revised Article IV. New Article V in revised version defines Board Officers (Chairman, Vice Chairman, Secretary, Treasurer, Financial Secretary) with roles, previously under Executive Officers. Chairman now also President, Vice Chairman as Vice President, etc.
Article VI: Election of Officers and Directors (Original) / Election of Directors (Revised)	Restructuring and updates	Changed to focus on Directors only, as Officers are now elected by Board. Updated nomination months (September-November). Removed Officer elections. Added absentee ballot specifics.
Article VII: Installation of Officers (Original) / Installation of Board Members (Revised)	Minor updates	Changed to "Board Members" installation. Oath remains similar.
Article VIII: Removal of Executive Officers (Original) / Meetings (Revised)	Restructuring	Original Article VIII removed (now addressed in Article IV). New Article VIII covers all meetings (Association Meetings), combining previous Articles IX details with updates like electronic recording restrictions (8.2.1), updated order of business (8.3), agenda posting (8.4), quorums (8.5, 8.7), and conduct (8.6).
Article IX: Meetings (Original) / Obligations of the Members (Revised)	Restructuring	Original Article IX content moved to revised Article VIII. New Article IX defines member obligations and gender neutrality.
Article X: Obligations of the Members (Original) / Committees (Revised)	Restructuring	Original Article X moved to revised Article IX. New Article X details committees, expanding standing committees, adding reporting requirements, and financial submission timelines. Renamed/added committees like "Pistol East Range", "Pistol West Range".

Article XI: Committees (Original) / Property of the Association (Revised)	Restructuring	Original Article XI content moved to revised Article X. New Article XI covers property ownership, management, conveyance (added small item disposal), left dissolution options un-touched.
Article XII: Property of the Association (Original) / Limitation of Liability (Revised)	Restructuring	Original Article XII moved to revised Article XI. Revised Article XII mirrors original Article XIII with minor statute references.
Article XIII: Limitation of Liability (Original) / Disciplinary Action (Revised)	Restructuring	Original Article XIII moved to revised Article XII. New Article XIII expands disciplinary actions, adds executive sessions, updates notifications, and appeal processes.
Article XIV: Disciplinary Action (Original) / Membership Year, Fiscal Year (Revised)	Restructuring	Original Article XIV moved to revised Article XIII. New Article XIV adds annual budget requirement (14.1.1).
Article XV: Membership Year, Fiscal Year (Original) / Amendments (Revised)	Restructuring	Original Article XV moved to revised Article XIV. Revised Article XV updates amendment process with email/posting notifications.
Article XVI: Amendments (Original) / Effective Adoption (Revised)	Restructuring	Original Article XVI moved to revised Article XV. Revised Article XVI updates adoption dates, adding "2026".
Article XVII: Effective Adoption (Original)	Removed	Content moved to revised Article XVI with updated dates.

Overall	Additions and Formatting	Added Table of Contents. Increased total pages from 19 to 26 due to expansions. Multiple references to "General Membership Meeting" changed to "Association Meeting". Added privacy, safety, budget, and procedural details throughout.
